- a) Library Building discussion has been on going with our Asset monitoring unit and Finance for the project paper for the new National Library Building.
- **b) Collection** In terms of collection the department has \$700,000 specifically for the procurement of resources, hence the collection development for the libraries are very good. Procurement of e-books and audio books are the new formats that we have started in 2018, all this will be accessible once our website goes live.
- c) Access Provision of access to resources is provided through our branch libraries across Fiji and into our 45community libraries in the community. Community libraries are active as this is one way that we have increase access to information due to the geographical locations of communities.
- d) Services The department have the following services:

 - II. American Corner Western Division
 - III. China Corner Central Division
 - IV. School library services
 - V. Community library services
 - VI. Co-ordinate National Events to advocate on libraries.
