02. Overview of Major or New Developments in Library Buildings, Collections, Access or Services

i. Presently all 05 floors of the National Library and Documentation Services Board building is under refurbishment with all modern amenities.

ii. There are 24 collections in the library. Such as,

Main Collection; The main collection contains tertiary sources as General Books and Subject Encyclopedias, Dictionaries of Sinhala, Tamil and English Language, Other languages, Bilingual Dictionaries

Newspaper Collection; The National Library receives all the newspapers published in the country since 1976 to the present day.

Periodical Collection; the collection contains Sinhala, Tamil and English languages Periodicals.

Sri Lanka Government Publication Collection; This collection include publications such as Bills, Acts, Ordinances, Parliamentary Debates (Hanzards), Sessional Papers, Parliamentary Series, Gazettes, Sri Lanka Law Reports.

Theses and Dissertation Collection; Building of a theses and dissertation collection was commenced from to the present day.

Ola Leaf Manuscript Collection; The National Library has fairly good collection of ola – leaf manuscript and its development continuously.

Maps Collection; Special emphasis is given on building up a complete collection of maps relevant to Sri Lanka.

Collection for Readers with Special Needs; In order to build up a national collection of Braille literature for reader with special needs in the country, the National Library commenced acquiring Braille and large print books in June 1990. In addition the National Library has made an arrangement to collect audio books for the readers with Special Needs.

Drama Manuscript Collection; The National Library commenced building up a collection of Drama Manuscript in 1995.

Intangible Cultural Heritage Collection; Intangible Cultural Heritage (ICH) is promoted by UNESCO as a counterpart of the World Heritage which focuses mainly on the aspects of culture.

Information Repacking Collection; Information gathered from different sources such as books, periodical articles, newspaper articles, Internet etc.;

Audio Visuals and Micro form Collection; Audio visual materials and microform can be used by readers to obtain required information.

Digital Collection; There are 68,122 Information item digital collection such as books, Journals, Newspapers, Newspaper articles, Government Publications, Research Papers and Audio etc.

Special Collection; Martin Wickramasinghe Collection. A collection of the most veteran author of Sri Lanka.

- iii. National Library use a library management software packages called KOHA to give access to the Library Collection.
- iv. Currently there are several services that the National Library offer it's uses they are such as Reference Services, Internet & CD-ROM Services, Inquiry Services, Referral Services, Documentation Services, Inter – Library Loan Services, Database Searching Services, Scan Services, Current Awareness Services, Selective Dissemination of Information Services, Information Repackaging Services.

03. Collaborations with Libraries, Archives and Museums in the Country

i. The National Library of Sri Lanka is the only governmental body in the field of Library & Information Science which has legal power of advising the government regarding issues in the sector. According to the National Library and Documentation Services Board Act (NLDSB 1998) one of the functions of the National Library of Sri Lanka is "to promote, advise and assist in, the establishment, development and maintenance of library and documentation networks', including networks of public, school, academic, government and other libraries and documentation centers serving all sections of the communities in Sri Lanka". Therefore, the National Library has a major responsibility of development of all types of libraries in the country.

Library system of Sri Lanka can be divided to 04 categories.

- (A) Academic Libraries
- (B) Public Libraries
- (C) Special Libraries
- (D) School Libraries

The National Library organizes workshops for Public and School libraries. The National Library is organized limited programmes by zoom in the year 2022, because under the covid-19 pandemic situation.

ii. National Library of Sri Lanka gets a copy of the legal deposit from the National Archives of Sri Lanka under the Legal Deposit Law.

- iii. The National Library of Sri Lanka Collaboration with National Institute of Library and Information Sciences (NILIS), Sri Lanka Library Association and The Asia Foundation of Sri Lanka. The National Library of Sri Lanka (NLSL) could keep closer contact with these institutions in upgrading the contribution made by those institutions. The above organizations provide a formal education programmes in librarianship while the National Library of Sri Lanka generally conduct programmes related to Continuing Professional Development (CPD) of libraries. The NL conducts CPD programmes like workshops, seminars and conferences, lectures and in house training programmes.
- iv. Digital Library Development programme is conducting in close collaboration with Information and Communication Technology Agency (ICTA) of Sri Lanka

The National Library of Sri Lanka is the only institution that represents various international forums in the subject. It has power to make International Cooperation with external communities.
